FLASH INFORMATION ENTRY & RETRIEVAL VIA-THE-WEB

The purpose of the Flash Report is to alert fellow group members of pertinent changes/information in customer activity supplemental to the credit meetings and the Credit Report Booklets and our database. All reported information becomes historical information in the database and will appear on the bottom of the customers credit report.

Connect to our website at www.nacmnashville.com, click on the red **Member Login** button and then enter your password.

To send Express Notification Flash information to us...in the case of urgent or critical Flash info, you can use our exclusive “**EXPRESS GROUP NOTIFICATION**” feature. Click on **Flash Submittal** under **Group Functions** to display the Flash Entry Screen. Before clicking on the SUBMIT button to send the Express data, click on the YES button. This module is utilized when a member has critical information that needs to be distributed immediately to the entire group. “Critical” is defined as bankruptcy, fraud or other items that cannot wait for the next group flash report. NACM will review this information as soon as it is received, and if warranted, it will be sent as email to the entire group (if the data is not deemed critical, the submitting member will receive email stating that it is being held for the next report).

If we receive your aging, you can just type your customer's account number here and the name and address boxes will fill in automatically!

The Express Group Notification Feature lets you alert your fellow group members of urgent information, such as bankruptcy or fraud situations.

To retrieve Flash Reports...click on the report name under the **Downloads** heading. Flash files use the standard “RTF” format, and can be viewed or downloaded by any browser. You can open or save the file, and then print it using your browser's print function. Files are updated and are available based upon your group's standard schedule.
